Meeting Minutes

Middletown Township EAC – CAP subgroup

March 13, 2024

The meetings of the CAP subgroup are held as informal working sessions focused on tasks associated with the Climate Action Plan (CAP).

The meeting started at 5:30 PM and ended at 6:30 PM.

Agenda Items

Ten priority CAP tasks have been reviewed and discussed previously. See below. In many cases, action items had been identified and this meeting consisted of a recap of those topics.

Residential Buildings (RB)

- 1 1A (Home weatherization)
- 2 1E (Improve insulation)
- 3 3B (Educational workshops) Commercial Buildings (CB)
- 4 -4A (Recognition program) Waste/Recycling (WR)
- 5 1B (Single-use plastic bag alternatives)
 Engage elected body; determine scope; how to enforce?
- 6 1F (Repurposing unsold, consumable food) Recommend best approach and lead/facilitate effort
- 7 2C (Expand multi-family recycling)
 Apartment complexes and townhome communities
 Water (Masterwater (MAM)

Water/Wastewater (WW)

2C (Low/No cost residential retrofits)
 Explore grants, educational outreach, and business partnerships



Transportation (TR)

9 - 2E (Alternatives to salt for snow/ice removal)

Research and identify best practices; pilot potential alternatives

10 - 3C (Encourage commercial areas to add EV charging stations)

Discussion

Given the township's advancement in EV charging station installations, it is appropriate to put additional effort into Task TR-3C and encourage commercial installations. Some exist now at the Middletown Giant (New Falls Rd), AAA, and WaWa (Rte. 1). However, other locations with high potential such as Sesame Place and the OV Mall do not presently have installations. Contact attempts have been made in the past without response.

- Donna will do some research into contacts at Sesame Place to identify who we can communicate with regarding plans for EV charging stations at their property.
- We also need to identify a responsive contact for the OV Mall management to pursue the same inquiry.

Task CB—4A was also discussed regarding the potential to highlight a commercial entity that has presently installed EV charging stations (Giant, AAA, WaWa) which can serve the intentions for both tasks.

• Donna will discuss the preparation of a public acknowledgement with the Neshaminy students to enlist their support in developing the write-up.

The general topic of educational advertising touches on many of the CAP tasks. A **"Did you know?"** series of focused environmental facts was discussed as a potential project for the EAC in general and Neshaminy students in particular. These would be prepared for both print media (Township Guides) and for electronic billboards.

• Donna will discuss this potential during her outreach to the students.

Next CAP subgroup Meeting

April is a busy month for the EAC. A CAP subgroup meeting has not yet been scheduled for April. However, ongoing effort may warrant a meeting if significant developments occur.
