
# REORGANIZATION MEETING

The Middletown Township Board of Supervisors approved the 2025 budget during their December meeting, outlining a comprehensive financial plan to support the community's needs while maintaining fiscal responsibility. The 2025 budget includes \$45,141,954 in operational expenditures and \$3,509,000 in capital expenditures.
